The following judicial assignments are effective December 1, 2009. This Order supersedes Administrative Order 09-05.

1. Criminal Forfeitures shall follow the underlying criminal or traffic matter.

**2. Judge Hull:**

**Courtroom 112**

Felony, Juvenile and back-up on all other matters

Monday, Tuesday, and Friday mornings---felony returns, settings, and motions limited to 15 minutes

Wednesday mornings---Juvenile Delinquency returns, settings, and motions limited to 15 minutes

Thursday mornings---Non-Delinquency Juvenile returns, settings, and status, followed by felony returns, settings, and motions limited to 15 minutes.

Monday, Tuesday, Wednesday, Thursday, Friday afternoon, except jury weeks, prove-ups

Monday, Tuesday, Thursday, Friday afternoons---felony trials and hearings scheduled by the Court

Wednesday afternoons---Juvenile returns, motions, hearings and trials scheduled by the Court

Emergency Juvenile hearings shall be as scheduled by the Court

On Mondays, Tuesdays, and Wednesdays of designated jury weeks, only first return dates on felony matters may be scheduled without leave of Court.

**3. Judge McCann:**

**Courtroom 113**

Civil and back-up on all other matters;

Monday, Tuesday, Wednesday, Thursday, and Friday mornings---civil returns, settings, and motions limited to 15 minutes

Monday, Tuesday, Wednesday, Thursday, and Friday afternoons---civil trials and hearings set by the Court

All jury trial settings are set at 1:00 p.m. on the established day prior to the jury week in Courtroom 113.

No civil matters shall be scheduled before Judge McCann on the Mondays, Tuesdays, Wednesdays, or Thursdays of the designated jury weeks without leave of court.

**4. Judge Matekaitis**

**Courtroom 114**

Traffic, misdemeanor, and back-up on all other matters

Monday, Tuesday, and Wednesday mornings---traffic and misdemeanor returns, settings, and motions limited to 15 minutes

Monday, Tuesday, Wednesday afternoons---traffic and misdemeanor returns, settings, motions limited to 15 minutes and trials and hearings as set by the Court

Fifth Week Monday, Tuesday, Wednesday afternoons-civil trial overflow as needed

**5. Judge Abrahamson**

**Courtroom 115-Mondays, Tuesdays, Wednesdays, Thursdays**

Family, Child Support, Traffic, Misdemeanor, and back-up on all other matters

Monday, Tuesday, Wednesday morning---family returns, settings, and motions not exceeding 15 minutes

Monday, Tuesday, Wednesday, and Thursday afternoons---family and child support trials and hearings set by the Court

Thursday mornings---States Attorney and Attorney General Child support call

**Courtroom 114-Fridays**

Friday mornings--- traffic and misdemeanor returns, settings, and motions limited to 15 minutes

Friday afternoons---traffic and misdemeanor returns, settings, motions limited to 15 minutes and trials and hearings as set by the Court
