

Case Scheduling

The following judicial assignments are effective on April 16, 2018 per Administrative Order 18-2. Also listed are the days of the week and times that some Judges require certain matters to be heard.

All cases must be scheduled a minimum of 3 days prior to the court date.

Miscellaneous Notes:

- OP cases with CM cases are to be heard by the Misdemeanor Judge
- OP cases with D/F cases are to be heard by the Divorce/Family Judge
- OP cases with CF cases are to be heard by the Felony Judge
- Prove Ups are at 1:00 pm M-F (including Jury Weeks)
- All Jury Trial settings are to be heard in courtroom 113
- Traffic/Misdemeanor Judge may be assigned other cases (Prove ups and SC/LM Trials) by the presiding Judge during the 5th week of each month
- Detention hearings to be set at 11:00 am as needed in courtroom 116
- Shelter care hearings to be scheduled by the court
- Bond call shall be Monday - Friday at 1:00 pm in courtroom 113
- All Traffic/Misdemeanor cases to be set on Officer's key date
- Criminal Forfeitures shall follow the underlying criminal or traffic matter, if any.
- No matters shall be scheduled before Judges Pilmer/McCann on the Mondays, Tuesdays and Wednesdays of jury week without leave of court.
- OP's and Emergency Motions shall be heard by the ADMIN Judge on their respective Admin morning.
