**GLOBAL POSITIONING SYSTEM (G.P.S.) ORDER**

\_\_\_\_\_, herein after called defendant is hereby ordered to obey and follow the rules and conditions of this GPS order as commanded as a condition of bond or sentence pursuant to:

**BISCHOFF 725 ILCS 5/110-5 (f)**  **PRETRIAL SUPERVISION 725 ILCS 5/110-10**  **Juvenile/Adult/ Drug Court 730 ILCS 5/5-8A-1 et seq**  
He/she is further ordered to cooperate with all police departments and court service officers as part of this order and under penalty of Contempt of Court to obey the rules of this G.P.S. order. Defendant understands that violating any of these rules could cause him/her to be held in the Kendall County Jail or the Kane County Juvenile Justice Center.

THE DEFENDANT is hereby ordered:

- 1. The defendant is to comply with G.P.S. Monitoring through Kendall County Court Services.
- 2. The defendant shall abide by all other orders made by this Court in the above numbered cases and entitled cause of action and be present in Court at all times required by the Court.
- 3. The defendant shall abide by all instructions given to him/her by the Court, Court Services and its agents, for the proper maintenance, care, and utilization of G.P.S. equipment including permission for movement and charging instructions.
- 4. The defendant shall not move or disconnect the installed G.P.S. monitoring equipment if a unit is placed in their home.
- 5. The defendant shall be solely responsible for any expenses required to utilize this G.P.S. equipment (e.g. electricity).
- 6. Kendall County and its agents are not liable for any damages incurred as a result of the defendant being granted the opportunity to participate in the G.P.S. Monitoring Program or tampering with the monitoring device. Any and all damages which may result from participating in the G.P.S. Program or tampering with the monitoring equipment are solely the responsibility of the defendant and he/she does hereby indemnify and hold these above referenced individuals and agencies harmless from any loss therewith.
- 7. Defendant waives personal service of any Petitions to Revoke G.P.S. Monitoring, as well as any and all legal objections (hearsay, foundation, etc.) as to the admission of evidence.
- 8. Kendall County has no obligation to provide food, shelter, clothing, or medical and dental care to the defendant during the time of his/her participation in the G.P.S. Monitoring Program.
- 9. The defendant shall immediately report any problems with his/her, electrical equipment or service, or difficulties with the G.P.S. Monitoring equipment to Kendall County Court Services.
- 10. The defendant shall, in accordance with his order, have G.P.S. Monitoring Unit installed on his/her person and/or home and shall maintain said equipment in good condition.
- 11. The defendant:  shall hereby serve \_\_\_\_\_ days in the G.P.S. Monitoring Program  shall remain on G.P.S. Monitoring until further order of the Court.
- 12. The defendant shall hereby report to Kendall County Court Services in order to initiate the G.P.S. Monitoring Program:  **immediately**  on \_\_\_\_\_ at \_\_\_\_\_ am/pm  shall not be released from jail until Kendall County Court Services personnel have activated a device on their person.
- 13. Tampering with all installed equipment could result in the defendant being held in the Kendall County Jail or the Kane County Juvenile Justice Center as well as being charged with criminal offense(s).

- 14. The defendant shall sign all requested releases of information. This will include a release of information to allow G.P.S. staff to speak directly to the defendant's current or future employer(s)/ school(s).
- 15. The defendant shall not violate any criminal statutes of any jurisdiction. Any arrest of the defendant could result in the defendant's termination from the G.P.S. Program.
- 16. The defendant shall pay to the Clerk of this Court the sum of \$ \_\_\_\_\_ per day for the service. The payment is due on **Friday** of each week. Failure to pay the ordered amount each Friday could result in a violation being filed and the defendant being held in the Kendall County Jail or the Kane County Juvenile Justice Center.

17. The defendant shall *remain within the structure* of his/her place of residence located at \_\_\_\_\_ except as provided in this order with prior permission from the probation department.
