The G.A.L. shall investigate and report back to the court  orally  in writing with recommendations on the following disputed issues:

allocation of parental responsibilities  relocation  other \_\_\_\_\_.

The G.A.L.'s report shall be completed no later than \_\_\_\_\_, 20\_\_-, unless otherwise ordered. Copies of written reports shall be submitted to all attorneys of record, pro se litigants, and the Court on or before the date designated herein.

The G.A.L. shall further make recommendations regarding the need for an appointment pursuant to:  
 SCR 215 (physical/mental exam)  Section 604.10(b) (court's professional)  
 Section 604.10(c) (party retained professional)  Section 604.10(d) (court's investigator)

The parties/litigants shall contact the G.A.L. within 24 hours to schedule interviews and home visits, if applicable, and shall immediately make the child(ren) and their respective homes available to the G.A.L. for investigative purposes.

The parties/litigants shall pay an initial retainer to the G.A.L. in the amount of \$\_\_\_\_\_, with payment due no later than \_\_\_\_\_ days from the date hereof. Payment of the initial retainer shall be allocated between the litigants as follows:
